  - ✓ The questions shall be set/moderated such that the student can comfortably answer each question within 20 minutes.
4. If any candidate is unable to attend the Semester End Supplementary Examinations due to mobility restrictions/affected by COVID-19 Pandemic, such students can appear for the Supplementary Exams later, which shall be scheduled later.
