- 13.3 Revised paper pattern and evaluation criteria (One-time) for the Semester End Examinations of B.Tech. and M.Tech. programmes under R15, R18 and R19 academic regulation in the academic year 2019-2020 due to COVID-19 pandemic.
  - Council resolved to follow the guidelines/instructions as stipulated by the JNTU Hyderabad and UGC/AICTE New Delhi with regard to conducting examinations of B.Tech. II semester (R19), B.Tech. IV semester (R18), B.Tech. III & IV year II semester (R15) and M.Tech. II semester (R18) for the academic year 2019-2020.
  - Members deliberated upon and approved the paper pattern and evaluation criteria of semester end examination and sessional/mid examination of B.Tech. II semester (R19), B.Tech. IV semester (R18), B.Tech. III & IV year II semester (R15) and M.Tech. II semester (R18) for the academic year 2019-2020 and resolved the following guidelines as a one-time measure due to COVID-19 pandemic.

# B.TECH. QUESTION PAPER PATTERN FOR II MID EXAMINATION (ONE TIME DUE TO COVID-19 PANDEMIC)

- Mid examination shall be conducted for a duration of 50 minutes.
- Maximum marks of mid examination shall remain the same i.e., 30 Marks.
- > There shall be **no compulsory section** with short answer questions.
- > The questions shall be set/moderated such that the students can comfortably answer each question within 15 minutes time.
- > There shall be a total of **5 questions**. Each question shall carry a weightage of **10 Marks**. There shall be **no sub-questions or bits**.
- > There shall be ONE question each from III, IV and V units i.e., 3 questions and the remaining 2 questions from any of III, IV and V units. There shall not be more than 2 questions from a single unit.
- > Student shall answer "3 out of 5 questions:" i.e.,

 $3 \times 10 M = 30 M$ 

## **B.TECH. QUESTION PAPER PATTERN**

## FOR <u>SEMESTER END EXAMINATION</u> (ONE TIME DUE TO COVID-19 PANDEMIC)

- > All the semester end examinations shall be conducted for a duration of 2 hours.
- > Maximum marks of external examination shall remain the same i.e., 60 Marks.
- > There shall be **no compulsory section** with short answer questions.
- > The questions shall be set/moderated such that the students can comfortably answer each question within 20 minutes time.
- > There shall be a **total of 8 questions**. Each question shall carry a weightage of **12 Marks**. There shall be **no sub-questions or bits**.
- > There shall be one question from each unit i.e., 5 questions
- Remaining 3 questions shall be framed from any of the 3 units out of the 5 units
- > Student shall answer "5 out of 8 questions" i.e.,

 $5 \times 12 M = 60 M$ 

# B.TECH./M.TECH. QUESTION PAPER PATTERN FOR <u>SESSIONAL EXAMINATION</u> (ONE TIME DUE TO COVID-19 PANDEMIC)

### ::SESSIONAL-I::

- > Sessional examination-I shall be conducted for a duration of 50 minutes.
- Maximum marks of sessional examination shall remain the same i.e., 30 Marks.
- > There shall be **no compulsory section** with short answer questions.
- > The questions shall be set / moderated such that the students can comfortably answer each question within 15 minutes time.
- > There shall be a **total of 5 questions**. Each question shall carry a weightage of **10 Marks**. There shall be **no sub-questions or bits**.
- > There shall be one question each from I, II and III units i.e., 3 questions

- Maximum marks of sessional examination shall remain the same i.e., 30
  Marks.
- > There shall be **no compulsory section** with short answer questions.
- > The questions shall be set / moderated such that the students can comfortably answer each question within 15 minutes time.
- > There shall be a **total of 5 questions**. Each question shall carry a weightage of **10 Marks**. There shall be **no sub-questions or bits**.
- > There shall be one question each from IV, V and VI units i.e., 3 questions
- Remaining 2 questions shall be framed from any of the IV, V and VI units only. There shall not be more than 2 questions from a single unit.
- > Student shall answer "3 out of 5 questions" i.e.,

 $3 \times 10 M = 30 M$ 

# B.TECH./M.TECH. QUESTION PAPER PATTERN FOR <u>SEMESTER END EXAMINATION</u> (ONE TIME DUE TO COVID-19 PANDEMIC)

- All the semester end examinations shall be conducted for a duration of 2 hours.
- Maximum marks of external examination shall remain the same i.e., 60 Marks.
- > There shall be **no compulsory section** with short answer questions.
- > The questions shall be set / moderated such that the students can comfortably answer each question within 15 minutes time.
- > There shall be a **total of 8 questions**. Each question shall carry a weightage of **10 Marks**. There shall be **no sub-questions or bits**.
- > There shall be one question from each unit i.e., 6 questions
- > Remaining 2 questions shall be framed from I, II and III units only.
- > Student shall answer "6 out of 8 questions" i.e.,

- 13.4 Approval of promotion guidelines of B.Tech. I, II, III & IV year and M.Tech. I & II year students in the academic year 2019-2020 due to COVID-19 pandemic.
  - In line with the guidelines given by the AICTE New Delhi and JNTU
    Hyderabad regarding student promotions in the academic year 20192020, the detailed guidelines as given below were placed before the
    council for approval.
    - ✓ There shall be no credit based detentions for the academic year 2020-2021. This relaxation shall be applicable to all the regular students as well as to all the students who were detained in the previous academic years (and not attending classes) due to shortage of credits.
    - ✓ Student attendance during the II semester of the academic year 2019-2020 shall be calculated as follows:

i) Attendance of all the days during which the physical class work was conducted shall be counted at par and

ii) Full attendance shall be given to the students during the entire lockdown period i.e., a student shall be deemed to be present for all the online classes conducted from the date when the lockdown (due to corona pandemic) was announced by the Government of Telangana.

Considering the above two parameters, the lists of students who are detained due to shortage of attendance shall be prepared and approved in the meeting of Institute Academic Committee.

 Council approved the above mentioned guidelines as stipulated by the JNTU Hyderabad and UGC/AICTE New Delhi regarding attendance and promotion of B.Tech. I, II, III & IV year II semester & M.Tech. I year II semester students for the academicyear 2019-2020.
