State Government of Andhra Pradesh and others etc. and later judgments.

In the event of infringement/contravention or non-compliance of any of the conditions, guidelines, norms, and regulations prescribed by the AICTE from time to time the AICTE or a body or person(s) authorized by it shall be free to take measures for withdrawal of the approval or recognition without consideration of any related issues and that liabilities arising out of such withdrawal shall be sole responsibility of the Management/Trust/Society and/or Institutions. AICTE may also inspect the institution at any time it may deem fit to note progress.

You are requested to kindly take appropriate action to implement the decision of the AICTE and continuously monitor the progress made by the institution and communicate it to the Southern Regional Committee of the AICTE under intimation to this office.
