# ACADEMIC RULES AND REGULATIONS OF FOUR-YEAR B.TECH. REGULAR DEGREE PROGRAMME APPLICABLE FOR THE STUDENT BATCHES ADMITTED FROM THE ACADEMIC YEAR 2022 – 2023

#### **1.0 PREAMBLE:**

Vallurupalli Nageswara Rao Vignana Jyothi Institute of Engineering and Technology (VNRVJIET) aims at achieving academic excellence by implementing new initiatives in teaching-learning and evaluation processes. Based on the directions of the University Grants Commission (UGC), New Delhi, All India Council for Technical Education (AICTE), New Delhi and Jawaharlal Nehru Technological University (JNTU) Hyderabad, VNRVJIET introduced the Choice Based Credit System (CBCS) in both the under-graduate and post-graduate programmes offered from the academic year 2015 – 2016. Keeping in view of the standardization of the higher education system in India, VNRVJIET is continuing the implementation of CBCS ahead. In line with the **National Education Policy (NEP) 2020**, many of the NEP reforms and initiatives have been implemented under these academic regulations and curriculum. Some of the initiatives are listed below:

- Courses on environment, sustainability and gender sensitization
- Certificate courses
- Student Induction Program

#### **2.0 SHORT TITLE, APPLICATION AND COMMENCEMENT:**

- These regulations shall be called as the "VNRVJIET B.Tech. Choice Based Credit System (CBCS) Academic Regulations, 2022". In short, it shall be referred as 'VNRVJIET B.Tech. CBCS R22 Regulations'.
- The regulations are quite comprehensive and include definitions of key terms, semester system, credit system, grading system and other relevant details.
- The regulations detailed herein shall apply to all the regular and professional under-graduate programmes offered by the Institute.
- These regulations shall be applicable and come into force to the student



batches admitted from the academic year 2022-2023 onwards.

- The Institute may revise, amend or change the regulations, scheme of examinations and syllabi, from time to time, if found necessary and on approval by the Academic Council of the Institute, keeping the recommendations of the BoS in view.
- Any or all such amendments shall be effective from such date and to such batches of students including those already undergoing the programme, as may be approved through Academic Council of the Institute.

#### **3.0 CHOICE BASED CREDIT SYSTEM:**

- The Choice Based Credit System (CBCS) enables a student to obtain a degree by accumulating the required number of credits prescribed for that degree. Under the CBCS, the requirement for awarding a degree is prescribed in terms of number of credits to be completed by the students. The number of credits earned by the student reflects the knowledge or skill acquired by him / her. Each course is assigned with a fixed number of credits based on the contents to be learned. The student also has choice in selecting the courses out of those offered by the various departments. The grade points earned for each of the course reflects the student's proficiency in that course.
- The CBCS provides the student flexibility in duration to complete a programme of study. The CBCS facilitates transfer of credits earned in different departments or institutions of higher education in India.
- The CBCS permits students to:
  - 1. Choose electives from a wide range of elective courses offered by the departments.
  - 2. Undergo additional courses of interest.
  - 3. Adopt an interdisciplinary approach in learning.
  - 4. Make the best use of expertise of the available faculty.

#### **7.0 ELIGIBILITY FOR ADMISSION:**

The eligibility criteria for admission into B.Tech. degree programmes offered at VNRVJIET shall be as prescribed by the Government of Telangana. The criteria are given below:

- The candidate shall be an Indian National / NRI.
- The candidate should have completed 16 years of age as on 31<sup>st</sup> December of the academic year for which the admissions are being conducted.
- The candidate should have passed the qualifying examination (10+2) or equivalent as on the date of admission recognized by BIE, Telangana State.
- Seats in each programme in the Institute are classified into two categories i.e., Category – A and Category – B as per the Government Orders.



#### • Category – A Seats

These seats shall be filled through counseling as per the rank secured by a candidate in the Entrance Test (EAMCET) conducted by the Government of Telangana and as per other admission criteria laid down in the Government Orders.

#### • Category – B Seats

These seats shall be filled by the Institute as per the Government Orders issued by the Government of Telangana from time to time.

#### • Direct Admission to Second Year: (Lateral Entry Scheme)

A candidate shall be admitted into the III semester (II year I semester) based on the rank secured by the candidate in the Engineering Common Entrance Test [ECET (For Diploma Holders)] by the Government of Telangana and as per other admission criteria laid down in the Government Orders.

#### **8.0 MEDIUM OF INSTRUCTION:**

The medium of instruction for the entire B.Tech. programmes shall be **English** for all the courses including their content delivery and examinations, seminars, presentations, and project evaluation as prescribed in the programme curriculum.

#### **9.0 B.TECH. PROGRAMME STRUCTURE:**

The structure of the B.Tech. programmes on offer at VNRVJIET are based on the **Choice Based Credit System (CBCS)** and **Credit Based Semester System (CBSS)** as defined by the UGC and the curriculum / course structure as suggested by the AICTE in its Model Curriculum.

#### **Semester Scheme:**

- The B.Tech. programmes offered at VNRVJIET follow **semester scheme** pattern.
- The duration of a B.Tech. programme shall be of **4 academic years**.
- Each academic year shall have **2 semesters** i.e., odd and even semesters and shall be counted as I semester, II semester, III semester, IV semester and so on upto VIII semester.
- Each semester shall consist of **22 weeks** (≥90 instructional days) of academic work including examination and evaluation.
- Each semester is structured to provide credits totaling to **160 credits** for the entire B.Tech. programme.
- Each semester shall have **'Continuous Internal Evaluation (CIE)'** and **'Semester End Examination (SEE).'**
- Each student shall secure a total of 160 credits with a CGPA ≥ 5 required for the completion of the B.Tech. programme and the award of the B.Tech. degree.
- A student after securing admission into a B.Tech. programme at VNRVJIET shall pursue and acquire the B.Tech. degree in a minimum period of four academic years i.e., 8 semesters and a maximum period of eight academic years i.e., 16 semesters starting from the date of commencement of I semester (I year I semester), failing which the student shall forfeit the seat in B.Tech. programme.



#### **10.0 DURATION OF THE ACADEMIC PROGRAMMES:**

• Under CBCS, programme duration shall be defined by the period in which a student earns the prescribed credits for the award of B.Tech. degree.

#### Normal Duration:

- The duration of the B.Tech. degree programme shall be **four years.**
- The duration of the B.Tech. degree programme for students admitted under lateral entry scheme (LES) shall be **three years**.

#### **\* Maximum Duration:**

- The maximum period in which a student can complete a full time B.Tech. degree programme shall be twice the normal duration of the programme, i.e., eight years (16 semesters) for B.Tech. degree and six years (12 semesters) for students admitted under lateral entry scheme (LES) i.e., (For Diploma Holders) respectively.
- The maximum period for a programme shall also be dictated by the fact that a student has to demonstrate the prescribed minimum academic performance by registering for the prescribed number of credits in every semester, for continuing in the programme. This period can be equal to or lesser than the maximum period indicated as indicated above.

#### **11.0 COURSES AND CREDIT STRUCTURE:**

• Every course in the B.Tech. programme of study has a Lecture-Tutorial-Practical (L-T-P) component attached to it. Based upon the L-T-P structure, the credits are allotted to a course using the criteria as shown in the Table 2.

- Courses like Induction Programme, Environmental Science, Intellectual Property Rights, Happiness and Well Being, Ancient Wisdom, Gender Sensitization, Constitution of India are mandatory audit courses. These courses shall not carry any credits.
- Every course of the B.Tech. programme shall be offered by a specific section / department. The unique codes of the section / department offering the courses are given in the Table 3.

# Structure: Every B.Tec

- Every B.Tech. programme of study shall be designed to have theory and laboratory courses. In addition, a student shall carry out skill development course, field project, internship, industry oriented mini-project, project, design thinking and other courses as prescribed in the curriculum of the programmes.
- Every course offered under a B.Tech. programme shall be placed in one of the course categories with minimum credits as listed in the Table 4.
- The course group / category along with their broad classification and description are listed in the Table 5.

# **12.0 REGISTRATION / DROPPING/ OFFERING OF COURSE(S):**

#### **Course Registration:**

- All the students must compulsorily register for course work at the beginning of each semester as per the schedule mentioned in the Academic Calendar.
- It is essential for the students to register for all the prescribed courses in time.
- The registration shall be organized by the department under the supervision of the Head of the Department.
- Every course may have one or more of its preceding course(s) as prerequisite(s).
- A 'faculty advisor or mentor or counselor' shall be assigned to a group of 20 students, who shall advise them about the B.Tech. programme, its course structure and curriculum, choice / option for course / courses, based on their competence, progress, pre-requisites if any and interest.
- The academic section of the college shall invite 'registration forms' from students before the beginning of the semester through **`on-line registration,'** ensuring **`date and time stamping'**.
- The on-line registration requests for any 'current semester' shall be completed before the commencement of SEEs (Semester End Examinations) of the 'preceding semester.'
- A student shall register courses online with the approval of faculty advisor or mentor or counselor.' A copy of it shall be retained by the student and other copies be submitted online to the concerned HoD, faculty mentor and Dean of Academics.
- A student may be permitted to register for all the courses in a semester with credits as prescribed in the course structure of the concerned B.Tech. programme with maximum additional course(s) limited to 6 credits (any 2 elective courses), based on the progress and SGPA / CGPA, and completion of the 'pre-requisites' as indicated for various courses, in the course structure of the programmes and syllabus contents.
- Choice for 'additional courses', not more than any 2 elective courses in any semester, must be clearly indicated, which needs the specific approval and signature of the faculty advisor or mentor or counselor and HoD.
- Additional courses shall be offered only upon meeting the prerequisites, if any, as mentioned in the programme curriculum.
- If the student submits ambiguous choices or multiple options or erroneous entries during on-line registration of the courses as listed in the course structure, only the first mentioned course shall be taken



into consideration and shall be treated as FINAL choice.

- Course options exercised through 'on-line registration' shall be FINAL and cannot be changed or inter-changed; further, alternate choices also shall not be considered.
- However, if the course that has already been listed for registration by the Head
  of the Department in a semester could not be offered due to any unforeseen
  or unexpected reasons, then the student shall be allowed to have alternate
  choice either for a new course (subject to offering of such a course), or for
  another existing course (subject to the availability of seats). Such alternate
  arrangements shall be made by the Head of the Department, with due
  notification and time-frame schedule, within the **first week** after the
  commencement of classwork for that semester.
- **IN ABSENTIA** registration **shall not be permitted** under any circumstance.
- At the time of registration, students should have cleared all the dues of Institute and Hostel (if applicable) in the previous semesters, paid the prescribed fees for the current semester and not been debarred from Institute for a specified period on disciplinary or any other ground.

#### \* Open Elective Courses:

- The students have to choose **one open elective course (OE-I) in V semester, one (OE-II) in VI semester, one (OE-III) in VII semester and one (OE-IV) in VIII semester** from the list of open electives offered by other departments and as prescribed in the course structure of the programme.
- However, the **student cannot opt for an open elective course offered by his/her own (parent) department**, if it is already listed under any category of the courses offered by parent department in any semester.
- Open elective courses that are already studied by a student cannot be pursued again/repeated even if offered.
- Open elective courses should not match with any course category (Professional Core, Professional Electives, Mandatory Courses etc.) even in the forthcoming semesters.

#### Professional Elective Courses:

- Students shall register for a total of 06 professional elective courses (PE-I to PE-VI) from the list of professional elective courses as prescribed in the course structure of the programme.
- Compulsory core courses can be chosen by the students of the respective disciplines only.
- However, the students of a particular discipline can register for discipline / interdisciplinary courses of other disciplines provided they have met the prerequisite or when the pre-requisite is waived by Dean of Academics. Courses that are already studied by a student cannot be pursued again/repeated even if offered.
- In case of options from students of other departments/branches/disciplines for professional elective courses (not open elective courses), first priority shall be given to the student of the parent department.

#### **\* Dropping of Courses:**

 Dropping of one or more courses may be permitted, only after obtaining prior approval from the faculty advisor or mentor or counselor (subject to retaining of minimum credits as prescribed in these regulations), 'within a period of



**15 days**' from the beginning of the current semester for maintaining studentship.

- The dropped courses are not recorded in the Grade Card.
- Student must complete the dropped course by registering them as and when offered in the next semester in order to earn the required credits. This is in addition to the minimum number of credits that are required to continue studentship in a semester. However, the total credits registered in a semester should not exceed the maximum number of credits permitted to register in that semester.

#### **Courses to be Offered:**

- A typical section (or class) strength for each semester shall be **60**.
- A course may be offered to the students, **only if a minimum of 15 students** opts for it. The **maximum strength** of a section is limited to **80 (**60 + 1/3 of the section strength).
- More than one faculty member may offer the same course in any semester.
- Laboratory / practical may be included with the corresponding theory course in the same semester.
- However, in case of elective courses, selection / allotment of courses, based on the choice for students, shall be based on - `FIRST COME FIRST SERVE and CGPA criterion' basis in the ON-LINE registration mode.
- If more entries for registration of a course are received, then the HoD concerned shall decide, whether or not to offer such a course for two (or multiple) sections keeping in view the resources available in the department offering the course.

#### **13.0 ATTENDANCE REQUIREMENTS AND DETENTION POLICY:**

- A student shall maintain a **minimum required attendance** of **75%** in **AGGREGATE** to be eligible to appear for the Semester End Examinations.
- Minimum required attendance of 75% shall be maintained in all the mandatory courses offered in a semester like Induction Programme, Environmental Science, Intellectual Property Rights, Happiness and Well Being, Ancient Wisdom, Gender Sensitization, Constitution of India etc.
- **Two periods** of attendance for each theory course shall be considered if a student appears for the sessional examination of that course.
- Shortage of attendance upto 10% i.e., attendance between 65% to 75% in aggregate, may be condoned by the Institute Academic Committee based on the rules prescribed by the Institute Academic Committee from time to time.
- Shortage of attendance below 65 % shall in NO CASE be condoned.
- A stipulated fee, as fixed by the Institute, shall be payable towards condonation of shortage of attendance.
- Students whose shortage of attendance is not condoned OR who have not paid the stipulated fee OR who have not cleared any other fee dues to the Institute in any semester are not eligible to write the Semester End Examination (SEE).
- Students, who do not meet the minimum required attendance in a semester, shall be detained in that semester and their registration for that semester shall stand cancelled, including all academic credentials (internal marks etc.) of that semester. They shall not be promoted to the next semester.
- Students detained in a semester shall seek re-admission into that semester as



and when offered again.

- Academic regulations applicable to the semester in which re-admission is sought shall be applicable to the re-admitted student.
- In case if there are any professional electives and/or open electives, the same may also be re-registered if offered. However, if those electives are not offered in the later semesters, then alternate electives may be chosen from the **same** set of elective courses offered under that category.
- Any student against whom any disciplinary action is pending shall not be permitted to attend semester end examination (SEE) in that semester.
- A student fulfilling the attendance requirement in the present semester shall not be eligible for re-admission into the same class.

#### **14.0 MINIMUM ACADEMIC REQUIREMENTS:**

- In addition to the attendance requirements mentioned in **13.0** of these regulations for the award of B.Tech. degree, a student must satisfy the minimum academic requirements as given below:
- A student shall be deemed to have satisfied the minimum academic requirements and earned the credits for each **theory, practical, design and drawing** course in B.Tech. programme, if student secures
  - A minimum of 35% marks (14 marks out of 40 marks) for each course in the continuous internal evaluation (CIE)
  - A minimum of 35% marks (21 marks out of 60 marks) for each course in the semester end examination (SEE), and
  - ✓ A minimum of 40% marks (40 marks out of 100 marks) for each course considering both CIE and SEE taken together.
  - $\checkmark$  In terms of letter grades, a **'C**' grade and above in that course.
  - ✓ A student is eligible to write Semester End Examination of the concerned course, if the student scores ≥ 35% marks (i.e., 14 marks out of 40 marks) in CIE.
  - ✓ In case, the student appears for Semester End Examination (SEE) of the concerned course but fails to score minimum 35% marks in CIE (i.e., 14 marks out of 40 marks), then his/her performance in that course in SEE shall stand cancelled inspite of student appearing for the SEE.
- A student shall be deemed to have satisfied the minimum academic requirements and earned the credits allotted to I year - Elements of CE/EEE/ME/ECE/CSE/EIE/IT/AE courses and II year - Field Project courses, if student secures
- A minimum of 40% of total marks (20 marks out of 50 marks) in CIE
- A student shall be treated as **failed**, if he
  - remains absent during the schedule in I year Elements ... and II year
     Field project courses, OR
  - secures less than 40% marks (20 marks out of 50 marks) in I year
     Elements ... and II year Field project courses, OR
  - ✓ does not submit a report in Field project courses OR
  - does not make a presentation of the same before the evaluation committee as per the schedule in Field project courses
- A student shall be deemed to have satisfied the minimum academic requirements and earned the credits allotted to Internship, Industry oriented mini-project, Project, Design thinking courses, if student secures
   A minimum of 40% of total marks (40 marks out of 100 marks) in
  - ✓ A minimum of 40% of total marks (40 marks out of 100 marks) in



each of the Internship, Industry oriented mini-project, Project and Design thinking courses

- A student shall be treated as **failed**, if he
  - does not submit a report in Internship, Industry oriented mini-project, OR
  - does not make a presentation of the same before the evaluation committee as per the schedule, OR
  - secures less than 40% marks (40 marks out of 100 marks) in overall evaluation in Internship/Industry oriented mini project.
    - ✓ In case of a student not meeting any of the above points, student may re-appear once for each of the evaluation of Field project, Internship, Industry oriented mini-project, as scheduled by the evaluation committee; if the student fails in such 'one re-appearance' evaluation also, student has to re-appear for the same in the next subsequent semester, as and when it is scheduled.
- In order to successfully complete the B.Tech. degree programme, a student shall
  - register for all the courses covering 160 credits as specified and listed in the course structure of the B.Tech. programme,
  - o fulfills all the attendance and academic requirements for 160 credits,
  - 'earn all 160 credits' by securing SGPA ≥ 5.0 (in each semester) and CGPA ≥ 5.0 (at the end of each successive semester)
  - $\circ$  passes all the mandatory courses
- The performance of the student in these 160 credits shall be considered for the calculation of the final CGPA (at the end of the B.Tech. programme) and shall be indicated in the grade card/marks memo of VIII semester (IV year II semester).
- If a student registers for 'extra courses' (in the parent department or other departments/branches of Engineering) other than those listed courses totaling to 160 credits as specified in the course structure of his department, then the performances in those 'extra courses' (although evaluated and graded using the same procedure as that of the required 160 credits) shall not be considered while calculating the SGPA and CGPA. For such 'extra courses' registered, percentage of marks and letter grade alone shall be indicated in the grade card / marks memo as a performance measure, subject to completion of the attendance and academic requirements as stated in items 13 and 14 above in these regulations.
- If a student fails to secure a pass grade in a particular course, it is mandatory that he shall register and reappear for the examination in that course during the next semester when SEE is conducted in that course. It is mandatory that he should continue to register and reappear for the examination till he secures a pass grade.
- A student eligible to appear in SEE of any course but remains absent from it or gets failed (failing to secure 'C' grade or above) may reappear for that course in the supplementary SEE as and when conducted. In such cases, CIE assessed earlier for that course shall be carried over and added to the marks to be obtained in the supplementary SEE examination for evaluating the performance in that course.
- A student detained in a semester due to shortage of attendance, may be re-admitted into the same semester in the next academic year for fulfillment of the academic requirements. Academic regulations applicable to the semester in which re-admission is sought shall be applicable to the re-



admitted student. However, no grade allotments or SGPA/ CGPA calculations shall be done for the entire semester in which the student has been detained.

- A student detained due to lack of credits, shall be promoted to the next year only after acquiring the required academic credits. Academic regulations applicable to the semester in which promotion is sought shall be applicable to the re-admitted student.
- A student shall register and put up **minimum academic requirement in all 160 credits and earn all 160 credits** for the award of B.Tech. degree.
- The student shall be qualified in two certificate courses of 40 hours duration each during his course of study. Out of the two certificate courses, atleast one certificate course shall be pursued through MOOCs platform like SWAYAM-NPTEL online courses, Coursera online courses, BEC certification courses etc.
- Students who fail to earn atleast 160 credits as indicated in the course structure within eight academic years counting from the year of their admission shall forfeit their seat in B.Tech. programme and their admission stands cancelled.

#### **15.0 PROMOTION RULES:**

• Apart from the minimum required attendance conditions as specified in 13.0 of these regulations, the credit conditions to be fulfilled by a student for getting promoted from the current semester to the next semester are given in the Table 6.

#### **16.0 DISTRIBUTION OF MARKS AND EVALUATION METHODOLOGY:**

The performance of a student in each semester shall be evaluated course wise with a maximum of 100 marks for theory and practical courses. I year course on Elements of Civil Engineering/Electrical & Electronics Engineering/Mechanical Engineering/Electronics & Communication Engineering/Computer Science & Engineering/Automobile Engineering and II year course on Field Project shall be evaluated for 50 marks. In addition, design thinking, internship, industry oriented mini-project, project stage-I and project stage-II courses shall be evaluated for 100 marks each.

#### **16.1 Theory Courses:**

- The syllabus for the theory courses shall be divided into **FIVE** units and each unit carries equal weightage in terms of marks distribution.
- For theory courses, the distribution of marks shall be 40 marks for Continuous Internal Evaluation (CIE) and 60 marks for the Semester End Examination (SEE).
- Continuous Internal Evaluation (CIE 40 M):
- Continuous Internal Evaluation (CIE) shall consist of sessional examination (SE 30 M), Class Assessment (CA 05 M) and Experiential Learning Assessment (ELA 05 M).
- > Sessional Examination (SE 30 M):
- For theory courses, two sessional examinations (SE-I and SE-II) shall be conducted in each semester as per the academic calendar. Each sessional examination shall be evaluated for 30 marks.



- The time duration of each SE shall be 2 hours.
- Question paper pattern for **SE** (**30 Marks**) shall be as follows:

#### PART-A: 5 X 2 M = 10 M

#### a. All questions are **compulsory**.

- b. 02 questions from Unit-I and Unit-II each and 01 question from first half of Unit-III in First sessional examination (SE-I)
- c. 01 question from second half of Unit-III and 02 questions from Unit-IV and Unit-V each in Second sessional examination (SE-II)

#### PART-B:

- 20 M a. There shall be a total of 06 questions.
- b. There shall be two questions from each UNIT with internal choice i.e., 'either' 'or' choice.
- c. Student shall answer **one question** from **each UNIT**.
- d. Part-B Paper pattern is as follows:

- First sessional examination (SE-I) shall be conducted on Unit-I, Unit-II and first half of the Unit-III.
- Second sessional examination (SE-II) shall be conducted on second half of the Unit-III, Unit-IV and Unit-V.
- Average of two SEs shall be calculated and used as the final sessional marks for each course.



- > Class Assessment (CA 05 M):
- **Two class assessments** consisting of any one of the alternative assessment tools (AAT) like **online quiz / assignment / objective exam etc.** shall be conducted covering the syllabus that is completed at the time of conducting the CA and evaluated for **05 marks** each.
- The first and second CAs shall be conducted during the instruction days as per the academic calendar.
- Average of two CAs shall be calculated and used as the final class assessment marks.
- The valuation and verification of answer scripts of CIE shall be completed within a week after the conduct of the examination.
- > Experiential Learning Assessment (ELA 05 M):
- Course project / course viva-voce / poster presentation / case study in the concerned course shall be conducted before Sessional Examination-I (SE-I) and Sessional Examination-II (SE-II) and evaluated for 05 marks.
- Average of two ELAs shall be calculated and used as the final sessional marks for each course.
- Semester End Examination (SEE 60 M):
- The SEE shall be conducted at the end of semester for a total of 60 marks.
- The **time** duration of the SEE shall be **3 hours**.
- The **syllabus** for the **theory courses** shall be divided into **FIVE units** and each unit carries equal weightage in terms of marks distribution.
- Question paper pattern for **SEE** (**60 Marks**) shall be as follows:
  - PART-A: 5 X 2 M = 10 M
    - a. There shall be **one question from each UNIT**.
    - b. All questions are **compulsory**.
    - PART-B: 5 X 10 M = 50 M
    - a. There shall be **two questions** from **each unit** with **internal choice** i.e., **`either' `or'** choice.
    - b. The student shall **answer one question** from **each UNIT**.
    - c. There could be a maximum of two subdivisions in a question i.e., (a) and/or (b).

#### **16.2 Practical Courses:**

- For practical courses, there shall be a **continuous internal evaluation (CIE)** during the semester for **40 marks** and **60 marks** for **semester end examination (SEE)**.
- CIE (40 marks) shall consist of

  - $\checkmark$  Analysis of data / results / graphs etc.
  - ✓ Course project report
  - ✓ Viva-voce on concerned laboratory course
- SEE shall be conducted by two examiners, one internal and other external concerned with the subject area from the same / other department / Industry.

#### NOTE:

• Any student who shall **remain absent for any of the CIE**, for any reason whatsoever, shall be deemed to have **secured 'zero' marks in the examination** and **no makeup examination shall be conducted**.

#### **16.3 Supplementary Semester End Examinations:**

- Supplementary examinations shall be conducted along with regular semester end examinations (SEE).
- During SEE of even semester, supplementary examinations of odd semester shall be conducted and during SEE of odd semester, supplementary examinations of even semester shall be conducted.

#### **16.4 Drawing and / or Design Courses:**

- For drawing courses like Engineering Graphics, Engineering Drawing, Computer Aided Engineering Graphics, Mechanical Drawing Practice etc., there shall be continuous internal evaluation (CIE) for 40 marks and 60 marks for semester end examination (SEE).
- CIE (40 marks) shall consist of

#### 16.5 I year - Elements of CE/EEE/ME/ECE/CSE/EIE/AE Courses:

- There shall be an elementary course in the respective discipline in I year like Elements of Civil Engineering / Elements of Electrical and Electronics Engineering / Elements of Mechanical Engineering / Elements of Electronics and Communication Engineering / Elements of Computer Science and Engineering / Elements of Electronics and Instrumentation / Elements of Automobile Engineering.
- These courses shall have continuous internal evaluation only for 50 marks.

- Student shall have to earn a minimum of 40% marks, i.e., 20 marks out of 50 marks for passing the course.
- There shall be **no external evaluation**.

#### **16.6 II year – Field Project Course:**

- There shall be a field-based research project course in II year.
- This course shall have **continuous internal evaluation only** for **50 marks**.
- The internal evaluation shall be on the basis of **two seminars** for **50 marks** one before SE-I and other before SE-II as defined in the academic calendar.
- Average of marks secured in two seminars shall be calculated and used as the final sessional marks.
- Student shall have to earn a **minimum of 40% marks**, i.e., **20 marks out of 50 marks** from average of the two seminars.
- There shall be **no external evaluation (SEE).**
- A student shall be treated as **failed**, if he
  - ✓ does not submit a report on the project, OR
  - does not make a presentation of the same before the internal committee as per the schedule, OR
  - ✓ secures less than 40% marks (20 marks out of 50 marks)

#### **16.7 Design Thinking Course:**

- 'Design Thinking' course leading to independent project shall be evaluated based on capstone project for **100 marks**.
- Evaluation of the course shall consist of both CIE and SIE.
- **CIE** shall be evaluated for **40 marks** by a committee consisting of Head of the Department, course coordinator/teacher and senior faculty member of the department.
- **CIE** shall be made on the basis of **two seminars** conducted and as per the evaluation format provided by the DoA.
- **SEE** shall be evaluated for **60 marks** by a committee consisting of Head of the Department, course coordinator/teacher and an external expert from industry.
- As part of the evaluation, a student shall submit a detailed report regarding the design idea and its conception into a prototype/simulation model etc.

#### **16.8 Internship / Industry Oriented Mini-Project:**

- There shall be a **summer internship / industry oriented mini-project** course.
- **Internship** shall be carried out at reputed industry/research organization/academic institution.
- **Industry oriented mini-project** shall be carried out in collaboration with an industry of their specialization.
- Student shall register for this course immediately after IV semester (II year II semester) End Examinations and pursue it during summer vacation/semester break & during III Year **without affecting the regular course work**.
- Course shall be evaluated for **100 marks** in the VI semester (III year II semester).
- There shall be **NO internal marks (NO CIE)** for this course.
- A student shall submit a detailed report and present it before the committee for evaluation.
- Evaluation shall be done by a committee consisting of an external examiner, Head of the Department, supervisor of industry oriented mini-project or internship, internal supervisor and a senior faculty member of the department.



#### 16.9 Project:

- A student shall initiate major project in VII semester (IV year I semester) and continue it in the VIII semester (IV year II semester).
- Project shall be carried out in two stages i.e. stage-I in the VII semester and stage-II in the VIII semester.
- Project shall be evaluated for a total of **200 marks**. Out of which, **project stage-I** shall be evaluated for **100 marks in VII semester** and **project stage-II** for **100 marks in VIII semester**.
- Evaluation of project stage-I and project stage-II shall consist of both CIE and SEE in each semester.
- **CIE** shall be carried out for **40 marks** both in stage-I and stage-II.
- CIE shall be done by a committee consisting of Head of the Department, project supervisor and senior faculty member of the Department.
- CIE shall be done on the basis of **two seminars** conducted in each semester as per the academic calendar and as per the evaluation format provided by the DoA.
- **SEE** shall be carried out for **60 marks** in both stage-I and stage-II.
- **SEE in stage-I** shall be conducted by a committee consisting of Head of the Department, the project supervisor and one senior faculty of the programme.
- The student is deemed to have failed in Project Stage-I, if he
  - ✓ does not submit a report, OR
  - does not make a presentation of the same before the evaluation committee as per schedule, OR
  - ✓ secures less than 40% marks in the sum total of the CIE and SEE taken together.
- A student who has failed may reappear once for the above evaluation, when it is scheduled again; if he fails in such 'one reappearance' evaluation also, he has to reappear for the same in the next subsequent semester, as and when it is scheduled.
- Evaluation of **Project Stage-II** in **VIII semester** shall consist of both **CIE** and **SEE**.
- CIE shall be carried out for 40 marks whereas SEE shall be carried out for 60 marks.
- CIE shall be done by an internal project committee consisting of Head of the Department, project supervisor and senior faculty member of the Department.
- Out of the **40 marks**, **internal project committee** shall evaluate the project work for **20 marks** and **Project Supervisor** shall evaluate for **20 marks**.
- CIE shall be done on the basis of **two seminars** conducted in VII and VIII semesters as per the academic calendar and as per the evaluation format provided by the DoA.
- **SEE in stage-II (project viva-voce)** shall be conducted by a committee consisting of an external examiner, Head of the Department, the project supervisor and one senior faculty of the programme.
- The topics for Industry Oriented Mini Project/ Internship/SDC etc. and the main Project shall be different from the topic already taken.
- The student is deemed to have failed in Project Stage-II, if he
  - $\checkmark$  does not submit a report, OR
    - does not make a presentation of the same before the External Examiner as per schedule, OR
  - ✓ secures less than 40% marks in the sum total of the CIE and SEE taken together.
- A student who has failed, may reappear once for the above evaluation, when



it is scheduled again; if student fails in such 'one reappearance' evaluation also, he has to reappear for the same in the next subsequent semester, as and when it is scheduled.

#### 16.10 MOOC:

- Meeting with the global requirements, to inculcate the habit of self-learning and in compliance with the UGC guidelines, MOOC (Massive Open Online Courses) have been introduced in these regulations.
- The proposed MOOCs would be additional choices in all the elective group courses subjected to their offering in the department, availability in the MOOC platform during the respective semesters as well as according to the guidelines specified by the Academic Section for offering of such courses at that time.
- As per the guidelines issued by the Academic Section regarding equivalency conditions of the MOOC, concerned departments shall declare the BoS approved list of the courses that a student can pursue through MOOCs at the beginning of the semester.
- Students interested in pursuing MOOCs shall register the course title at their department office before the start of the semester against the courses that are announced by the department.
- Course content for the selected MOOCs shall be drawn from the respective MOOCs link or shall be supplied by the department.
- Course progress shall be monitored by the course coordinator designated by the HoD.
- Assessment & evaluation of the courses shall be done by the respective department designated MOOC Coordinator.
- Grade obtained through the evaluation of the selected course pursued through MOOC shall be considered for the SGPA/CGPA calculation.
- Equivalent credits\* shall be awarded upon successful completion of each MOOC course.
- \*Detailed guidelines regarding credit transfer of the courses pursued through MOOC shall be issued time to time by the Academic Section.

#### **16.11 Value Added Courses:**

- The value-added courses / certificate courses offered through joint ventures with various industries / organizations provide ample scope for the students as well as faculty to keep pace with the latest technologies pertaining to their chosen field of studies.
- A plenty of value-added programmes approved by the BoS shall be proposed by the departments one week before the commencement of classes.
- The students are given the option to choose the course inclinations as per their choice.
- Students interested in pursuing value added courses shall register for the courses in the department office at the beginning of the semester against the courses that are announced by the department.
- Course progress shall be monitored by the course coordinator designated by the HoD.
- Result of value-added courses shall be declared with "Satisfactory" or "Not Satisfactory" performance.
- Grade obtained through value added course shall not be considered for the SGPA/CGPA calculation.



#### **16.12 Mandatory Audit Courses:**

- A student shall pursue the entire mandatory and audit courses as specified in the course structure of the B.Tech. programme.
- These courses are among the compulsory courses and **do not carry any credits**.
- Mandatory courses shall not carry any credits but, securing 40 marks out of 100, shall be necessary requirement for the student to qualify for the award of Degree.
- **Two sessional examinations** shall be conducted in each semester as per the academic calendar.
- Each sessional examination shall be evaluated for **50 marks**.
- Question paper pattern for **sessional examination (50 Marks)** of Mandatory Audit courses shall be as follows:

- **Sum total of two sessional examinations** shall be calculated and used as the final sessional marks.
- Result of mandatory audit courses shall be declared with "Satisfactory" or "Not Satisfactory" performance.
- No marks or letter grade shall be allotted.
- The students shall have four chances in total to clear a specific mandatory and audit course.



#### 16.13 Virtual Laboratories:

- The Virtual Laboratories are internet enabled experiments for remote operation so as to enhance the curiosity and innovation of students and provide handson sessions. The main aim of virtual labs is to enthuse the students about performing 'experiments' and thereby getting them interested in their respective disciplines in a meaningful way. It is expected that the competence level of the engineering students shall enhance through the use of these labs.
- Advanced laboratories / experiments that are not existing in the Institute and are required for supplementing the knowledge gained in specific course(s) may be pursued by the students though the use of Virtual Labs.
- Departments offering B.Tech. programmes shall define the list of virtual laboratories that a student can take up during the duration of course of study.
- The decision to pursue a virtual laboratory course by a student shall be optional and also in addition to the mandatory requirement of pursuing practical courses as specified in the course structure of the programme.
- The virtual laboratories / experiments that a student decides to pursue must be communicated to the Academic Section through HoD.

#### **17.0 RE-REGISTRATION OF COURSES:**

- A student can re-register for courses in a semester, if
  - ✓ Internal marks secured by student in continuous internal evaluation for 40 marks (sum of average of two sessional examinations, average of two class assessments and average of two experiential learning assessments) are less than 35% and failed in those courses.
- Such a student may seek re-registration for all those courses registered in that semester in which he has failed to score minimum 35% marks in CIE (i.e., 14 marks out of 40 marks). Student has to re-appear for CIE and SEE as and when offered.
- A student must **re-register** for such **failed course(s) within four weeks** of **commencement of the classwork in the next academic year**.
- In the event of the **student taking this chance**, his **CIE marks** for 40 **obtained in the previous attempt** shall **stand cancelled**.
- Student has to obtain a fresh set of marks in CIE for 40 marks (sum of average of two sessional examinations, average of two class assessments and two experiential learning assessment) and SEE (60 marks). Head of the Department shall coordinate for the re-registration activity.

# **18.0 CONDUCT OF SEMESTER END EXAMINATIONS AND EVALUATION:**

- Semester end examination (SEE) shall be conducted by the Controller of Examinations (COE) by inviting Question Papers from the External Examiners.
- Question papers may be moderated for the coverage of syllabus, pattern of questions by an examiner appointed by the CoE. The appointed examiner shall prepare a detailed answer key and scheme of valuation and submit it to the CoE.
- Laboratory SEE shall be conducted involving internal and external examiners as defined in these regulations.



#### **19.0 REVALUATION:**

- Student can register for the revaluation by paying a prescribed fee.
- The Controller of Examinations (CoE) shall arrange for the revaluation and declare the results.
- Revaluation shall not be permitted to the courses other than theory courses.

#### **20.0 PERFORMANCE AND GRADING SYSTEM:**

 Performances of students based on the percentage of marks obtained (CIE and SEE, both taken together) in each of the courses (Theory / Practical / Industry-Oriented Mini-Project / Internship / SDC and Project Stages) in the programme are expressed in terms of Letter Grades based on an **absolute grading** system. The 10-point grading system with letter grades and their grade points are shown in the Table 7.

- A student who has obtained an 'F' grade in any course shall be deemed to have 'failed' and is required to reappear as a 'supplementary student' in the semester end examination, as and when scheduled.
- In such cases, internal marks in those courses shall remain the same as those obtained earlier.
- If a student has not appeared for an examination in any course, 'Ab' grade shall be allocated in that course, and he is **deemed to have 'Failed'** and is **required to reappear** as a '**supplementary student**' in the semester end examination, as and when offered next.
- In this case also, the internal marks in those courses shall remain the same as those obtained earlier.
- A letter grade does not indicate any specific percentage of marks secured by the student, but it indicates only the range of percentage of marks.



#### **21.0 COMPUTATION OF SGPA AND CGPA:**

#### > CALCULATION OF SEMESTER GRADE POINT AVERAGE (SGPA):

• The performance of each student at the end of each semester shall be indicated in terms of SGPA. The SGPA shall be calculated as below:

 $SGPA = \frac{Total earned weighted grade points in a semester}{Total credits in a semester}$ 

$$SGPA = \frac{\sum_{i=1}^{P} C_i * G_i}{\sum_{i=1}^{P} C_i}$$

where

 $C_i$  = Number of credits allotted to a particular course 'i'  $G_i$  = Grade point corresponding to the letter grade awarded to the course 'i'

 $i = 1, 2, \dots, p$  represent the number of courses in a particular semester

# **NOTE: SGPA is calculated and awarded to those students who pass all the courses in a semester.**

#### > CALCULATION OF CUMULATIVE GRADE POINT AVERAGE (CGPA):

The CGPA of a student for the entire programme shall be calculated as given below:

• Assessment of the overall performance of a student shall be obtained by calculating cumulative grade point average (CGPA), which is weighted average of the grade points obtained in all courses during the course of study.

 $CGPA = \frac{Total earned weighted grade points for the entire programme}{Total credits for the entire programme}$

where

 $C_j$  = number of credits allotted to a particular course 'j'

 $G_j$  = grade point corresponding to the letter grade awarded to that course 'j'

j = 1,2,...m represent the number of courses of the entire programme.

• Grade lower than C in any course shall not be considered for CGPA calculation. The CGPA shall be awarded only when the student acquires the required number of credits prescribed for the programme.

- The above illustrated process of calculation of CGPA shall be followed for each subsequent semester until VIII semester i.e., (IV year II semester).
- The CGPA obtained at the end of VIII semester i.e., (IV year II semester) shall be the final CGPA secured by the student for the entire B.Tech. programme.



#### **22.0 DECLARATION OF RESULTS:**

- Computation of SGPA and CGPA are done using the procedure mentioned in 20.0.
- For final percentage of marks equivalent to the computed final CGPA, the following formula may be used.

#### % of Marks = (final CGPA – 0.5) x 10

#### **23.0 PASSING STANDARDS:**

- A student shall be declared successful or 'passed' in a semester, if he secures a GP ≥ 5 ('C' grade or above) in every course in that semester (i.e., when the student gets an SGPA ≥ 5.0 at the end of that particular semester)
- A student shall be declared successful or 'passed' in the entire B.Tech. programme, only when if he secures a CGPA ≥ 5.00 ('C' grade or above) for the award of the degree as required.
- After the completion of each semester, a grade card or grade sheet shall be issued to all the registered students of that semester.

#### 23.1 Grade Card:

The grade card issued shall contain the following:

a) Course code, course title, no. of credits for each course offered in that semester

- b) Letter grade and grade point awarded in each course
- c) Credits earned in each course
- c) SGPA/CGPA
- d) Total number of credits earned by the student up to the end of that semester.
- There is **NO exemption of credits** in any case.

#### 24.0 SCHEME FOR THE AWARD OF DEGREE:

#### 24.1 Award of B.Tech. Degree:

- A student shall be declared qualified for the award of the B.Tech. degree in the concerned branch of Engineering allotted at the time of admission, if he/she fulfils the following academic rules:
  - Pursued a programme of study for not less than four academic years and not more than eight academic years from the date of commencement of the first academic year.
  - ✓ Registered for 160 credits and secured a minimum of 160 credits with CGPA ≥ 5.0.

NOTE: Students, who fail to fulfill all the academic requirements for the award of the degree within eight academic years from the first academic year of their admission, shall forfeit their seat in B.Tech. programme.

#### 24.2 Awarding of Class based on CGPA:

• A student who qualifies for the award of the degree as listed in item 23.1 above shall be placed in the following classes based on their CGPA at the end of the B.Tech. degree programme.

#### \* Conditions for First Class with Distinction:

For a student to be awarded ` First Class with Distinction', he

(i) Should have passed all the courses in 'First Appearance' within the first 4 academic years (or 8 sequential semesters) from the date of commencement of first year first semester.

(ii) Should not have been detained or prevented from writing the semester end examinations in any semester due to shortage of attendance or any other reason.

- A student not fulfilling any of the above conditions with final CGPA > 8 shall be placed in 'First Class'.
- A student with final CGPA < 5.00 shall not be eligible for the award of the B.Tech. degree.
- Students **fulfilling the conditions** for awarding **First Class with Distinction** alone shall be eligible for award of 'Gold Medal'.

#### 24.3 Re-joining B.Tech. Degree after break:

- A student may be permitted to take **one year break** while pursuing four-year B.Tech. regular degree programme i.e., either after completion of B.Tech. IV semester (B.Tech. II year II semester) or B.Tech. VI semester (B.Tech. III year II semester).
- Student has to seek approval from the JNT University well in advance through the Institute Principal by submitting valid reasoning and documentary evidence.
- Students permitted by the University to take one year break can then re**enter** the four-year B.Tech. regular degree programme in the **next academic** year in the college and **complete the remaining degree** by fulfilling the academic requirements within the stipulated duration i.e., double the duration of the programme (within 8 years from the year of admission in first year).

#### 24.4 Award of Two-Year B.Tech. Diploma Certificate:

- A student willing to exit four-year B.Tech. regular degree program shall be awarded two-year B.Tech. Diploma Certificate in the concerned branch of engineering allotted at the time of admission, if he fulfills the following conditions:
  - $\checkmark$  submits a request for award of two-year B.Tech. Diploma certificate
  - ✓ completes all the minimum academic requirements upto B.Tech. IV semester (B.Tech. II year II semester) and
  - ✓ earns all the 80 credits upto **B.Tech. IV semester** (B.Tech. II year II semester) within 4 years from the date of admission in B.Tech. I year.
- Student once opted and awarded two-year B.Tech. Diploma Certificate



**shall be permitted to join the four-year B.Tech. degree programme only** in B.Tech. V semester (B.Tech. III year I semester) in the next academic year along with the next batch students. However, if any student wishes to continue the study after opting for exit, he/she should register for B.Tech. V semester (B.Tech. III year I semester) courses well before the commencement of classwork for that semester.

• Students who exit the four-year B.Tech. programme after II year of study and wish to re-join the B.Tech. degree programme must surrender the two-year B.Tech. (UG) Diploma Certificate awarded to him, subject to the eligibility for completion of Course/Degree.

#### 24.5 Award of B.Tech. Honors Degree:

- A student shall be awarded B.Tech. degree with Honors, if he secures additional 20 credits (over and above 160 credits for the regular B.Tech. degree) in III year and IV year only with atleast 7.5 CGPA for Honors and acquiring 160 credits successfully with atleast 7.5 CGPA for regular B.Tech. and passing all subjects in first attempt. Ex: B.Tech. (Honors) CSE
- Weekly instruction hours, internal & external evaluation and award of grades are on par with regular 4 year B.Tech. Program.
- No transfer of credits from courses of Honors programme to regular **B.Tech. degree** & vice versa.
- Eligibility Conditions:
- Students **pursuing V semester** (III year I semester) who have **passed all courses** in **first attempt in all the semesters with 7.5 or more CGPA** till the results announced.
- If more than 30% of the students in a branch fulfil the eligibility criteria (as stated above), the number of eligible students shall be limited to 30% based on the CGPA criteria till III semester (II year I semester).
- If a student fails in any registered course of either B.Tech. degree or Honors degree in any semester of four years program, then the student shall not be eligible for obtaining Honors degree and shall be eligible for only B.Tech. degree.
- Prior approval of faculty mentor / advisor and Head of the Department for the enrolment into Honors program, before commencement of V semester (III year I semester) is mandatory.
- **Courses** opted must be from the **prescribed list** as given in the Honors course structure and also **not studied/registered** in the **regular B.Tech. degree**.
- Student opting for Honors is not eligible to choose a Minor degree and vice-versa.
- Additional 20 credits secured for the Honors shall not be considered for CGPA calculation of B.Tech. degree.

#### 24.6 Award of B.Tech. Minor Degree:

- A student shall be awarded B.Tech. Minor degree in a specified programme if he secures additional 18 credits (over and above 160 credits for the regular B.Tech. Degree) during III year and IV year only.
   Ex: B.Tech. in Mechanical Engineering with Minor in Data Science
- If a student is unable to secure additional 18 credits in a specified duration (twice the duration of the course), then the student shall not be awarded Minor degree. However, if the student earns all the required 160 credits of B.Tech.,



then student shall be awarded only B.Tech. degree in the concerned branch.

- Weekly instruction hours, internal & external evaluation and award of grades are on par with regular 4 year B.Tech. Program.
- No transfer of credits from courses of minor programme to regular **B.Tech.** degree & vice versa.
- Student can **choose only one minor programme** along with his/her basic engineering degree.
- Student opting for minor programme shall not be eligible to choose honors degree and vice-versa.
- Eligibility conditions:
- Students shall **not have active backlogs till III semester** (II year I semester) while **entering into V semester** (III year I semester).
- If more than 50% of the students in a branch fulfil the eligibility criteria (as stated above), the number of eligible students shall be limited to 50% based on the CGPA criteria.
- Prior approval of faculty mentor / advisor and Head of the Department for the enrolment into minor programme before commencement of V semester (III year I semester) is mandatory.
- **Courses** opted must be from the **prescribed list** as given in the minor degree course structure and also **not studied/registered** in the **regular B.Tech. degree.**
- All these 18 credits need to be completed in III year and IV year only.
- Detailed instructions shall be issued by the Academic Section before commencement of V semester.

#### **25.0 CREDIT TRANSFER:**

• Credit transfer of a student from other Institution to VNRVJIET is permitted for under-graduate programme as per the GOs from the Government of Telangana.

#### \* Credit transfer from another Institution to VNRVJIET:

- A student studying in another Institution can take transfer to VNRVJIET against notification and orders issued by the Government of Telangana, under the following conditions:
  - ✓ When a student seeks transfer, equivalent credits shall be assigned to the student based on the equivalent courses studied earlier by the student.
  - ✓ The student, when transferred from other Institution, must follow the rules and regulations of VNRVJIET.
  - ✓ To graduate from VNRVJIET, a transferred student must study at least half of the minimum duration prescribed for a programme at VNRVJIET.

#### **Credit transfer facility through MOOC:**

• Detailed guidelines regarding credit transfer of the courses pursued through MOOC (NPTEL-SWAYAM) shall be issued time to time by the Academic Section.

#### **26.0 WITH-HOLDING OF RESULTS:**

 If a student has not paid the pending fee dues to the institute due to any reason whatsoever or if any case of indiscipline / malpractice is pending against him, the results of such student shall be withheld and shall not be promoted to the next semester as a punitive action.



• The issue of the award of the provisional certificate and the B.Tech. degree is liable to be withheld in such cases.

#### **27.0 DISCIPLINE:**

- Every student is required to observe discipline and decorum both inside and outside the institute and not to indulge in any activity which shall tend to bring down the honor of the institute.
- If a student exhibits indiscipline during the academic activities or indulges in malpractice in any of the theory / practical CIE or SEE, he shall be liable for punitive action as prescribed by the Institute from time to time.

#### **28.0 TRANSITORY REGULATIONS:**

#### **28.1 Students detained due to shortage of attendance:**

- A student who has been detained in any semester of B.Tech. I year of R18/R19/A19 academic regulations for want of attendance, shall be permitted to rejoin the corresponding semester of R22 academic regulations. Such a student is required to complete the B.Tech. regular degree programme within the stipulated period of eight academic years from the date of first admission in I year.
- A student who has been detained in any semester of B.Tech. II, III and IV years of R15 academic regulations for want of attendance, shall be permitted to rejoin the corresponding semester of R22 academic regulations. Such a student is required to complete the B.Tech. regular degree programme within the stipulated period of eight academic years from the date of first admission in I year.
- R22 academic regulations shall be applicable to the student from the semester of readmission onwards.
- He shall take up equivalent courses, as substitute courses in place of repeated courses as decided by the Chairman of the BoS of the respective departments.

#### **28.2** Students detained due to shortage of credits:

- A student of R15/R18/R19/A19 academic regulations who has been detained due to shortage of credits, shall be promoted to the next semester of R22 academic regulations only after acquiring the required credits as per the corresponding academic regulations of his first admission.
- He is required to complete the study of B.Tech. programme within the stipulated period of eight academic years from the year of his first admission in B.Tech. I year.
- R22 academic regulations shall be applicable to the student from the semester of readmission onwards.

#### **28.3 For readmitted students in R22 Academic Regulations:**

- A student who has failed in any course(s) under any regulation has to pass those course(s) in the same regulations.
- Minimum academic requirement of R22 academic regulation shall be applicable to all the readmitted students.
- Credit structure as defined in the course structure of B.Tech. programmes under R22 academic regulation shall be followed from the semester of readmission.
- The maximum credits that a readmitted student acquires for the award

of degree, shall be the sum of the total number of credits secured in all the regulations of his study including R22 regulations. There is NO EXEMPTION OF CREDITS in any case.

- If a student readmitted to R22 academic regulations, has any course with 80% of syllabus common with his previous regulations, then that particular course in R22 academic regulations shall be substituted by another course as suggested by the Board of Studies (BoS) of the concerned department.
- If a student readmitted to R22 academic regulations, has not studied any courses/topics in his/her earlier regulations of study which is prerequisite for further courses in R22 academic regulations, the department HoD concerned shall conduct remedial classes to cover those courses/topics for the benefit of the students.

#### **28.4 Student Transfer:**

- There shall be **no branch transfers** after the completion of admission process.
- Students seeking transfer to VNRVJIET from other colleges have to pass the failed courses which are equivalent to the courses of VNRVJIET and also pass courses of VNRVJIET which the students have not studied at the earlier college.
- Further, if some of the courses which the student has passed at the earlier college and are repeated in subsequent semesters of VNRVJIET curriculum, then the students have to study those courses again in VNRVJIET in spite of the fact that those courses are repeated.
- Student transferred from other college who are on rolls, shall be provided one chance to write the internal examinations in the equivalent course(s), as per the clearance (equivalence) letter issued by the University.
- The decision of the Institute Academic Committee shall be final in respect of equivalent courses suggested by the Board of Studies for those students who are transferred from other colleges.
- The transfer of students from other college to VNRVJIET is to be approved by the Academic Council and Governing Council of the Institute.

#### **29.0 MINIMUM INSTRUCTION PERIOD:**

• The minimum instruction period for each semester shall be **16 weeks** (excluding examinations).

#### **30.0 GENERAL:**

- The academic regulations should be read as a whole for the purpose of any interpretation.
- In the case of any discrepancy/ambiguity/doubt arising in the above rules and regulations, the decision of the Principal shall be final.
- The Chairman, Academic Council may change or amend any or all of the academic regulations or syllabi at any time and the changes or amendments made shall be applicable to all the students concerned with effect from the dates as notified by the Institute.
- Where the words "he", "him", "his", occur in the regulations, they include "she", "her", "hers".

# ACADEMIC REGULATIONS FOR B.TECH. - LATERAL ENTRY SCHEME (LES)

(Applicable for students admitted from the academic year **2023-2024**)

#### **31.0 MINIMUM ACADEMIC REQUIREMENTS:**

- Attendance requirements and detention policy of four-year B.Tech. regular degree programmes as specified in 13.0 of these regulations is adopted for students admitted to B.Tech. degree programme under lateral entry scheme (LES).
- Academic performance requirements as specified in 14.0 of these regulations are adopted for students admitted to B.Tech. degree programme under lateral entry scheme (LES).
- Student who fails to fulfill all the academic requirements for the award of the degree within six academic years from the year of his/her admission in B.Tech. II year, shall forfeit his/her seat in B.Tech. programme and his/her admission stands cancelled.

#### **32.0 PROMOTION POLICY:**

Apart from the minimum required attendance conditions as specified in 13.0 of these regulations, the credit conditions to be fulfilled by a Lateral Entry student for getting promoted from the current semester to the next semester are given below:

#### **33.0 SCHEME FOR THE AWARD OF DEGREE:**

#### **33.1 Award of B.Tech. Degree:**

- A lateral entry student shall be declared qualified for the award of the B.Tech. degree in the branch of Engineering allotted at the time of admission if he/she fulfils the following academic regulations:
  - Pursued a programme of study for not less than three academic years and not more than six academic years from the year of admission in B.Tech. II year.
  - ✓ Registered for 120 credits and secured a minimum of 120 credits with CGPA ≥ 5.0 from II year to IV year.
- Lateral Entry Scheme students are not eligible for two year B.Tech. Diploma Certificate.

#### Malpractices identified by squad or special invigilators:

Punishments shall be given to the students as per the above guidelines.

#### Malpractice identified at Spot center during valuation:

The following procedure shall be followed in the case of malpractice cases detected during valuation, scrutiny etc. at spot center:

1) Malpractice is detected at the spot valuation.

The case is to be referred to the malpractice committee. Malpractice committee shall meet and discuss/question the student and based on the evidence, the committee shall recommend suitable action on the student.

2) A notice is to be served to the student(s) involved, through the Principal, to his address and to the student(s) permanent address regarding the malpractice and seek explanations.

3) The involvement of staff who are in-charge of conducting examinations, invigilators, examiners valuing examination papers and preparing / keeping records of documents related to the examinations in such acts (inclusive of providing incorrect or misleading information) that infringe upon the course of natural justice to one and all concerned at the examinations shall be viewed seriously and recommend for award of appropriate punishment after thorough enquiry.

4) Based on the explanation by the party involved and recommendations of the committee action may be initiated.
