ADMISSION PROCEDURE:

1 **Undergraduate Programmes (UG):**

1.1 **Admission to the First year of 4-year B.Tech Degree Programme in Engineering and Technology:**

The admission into undergraduate engineering programmes (B.Tech) for all the branches of study are made as per the relevant Rules of the Govt. and norms/guidelines of the Telangana State Council of Higher Education:

- a. 70% of seats i.e., "**Category-A**" seats (based on the rank obtained in state level entrance examination-TSEAMCET) will be filled by the Convener, TSEAMCET.
- b. 30% of seats i.e., "**Category-B**" seats will be filled by the management as per the relevant rules of the State Govt. and guidelines of the State Council of Higher Education issued from time to time.

1.1.1 **Spot Admission Procedure for B.Tech. 4 year Course:**

Any seats left vacant in the convener quota, will be filled by the institution based on the guidelines given by Convener TSEAMCET.

Procedure:

The College issues an advertisement after necessary approval. The spot admissions will be made according to the guidelines issued from time to time by Convener TSEAMCET.

All admissions made at institution level (Spot Admissions and Category-B) are subject to approval of competent authorities.

1.2 **Admission to the second year of 4-year B.E Degree (Lateral Entry) Programme in Engineering:**

Seats upto 10% of the sanctioned intake of each programme of undergraduate course shall be filled by the Convener, TSECET as lateral entry admission into second year of B.E programme based on the merit ranks obtained by the students in TSECET (State Level Common Entrance Test).

1.2.1 **Spot Admission Procedure for B.Tech Lateral Entry:-**

Admission will be made based on the guidelines issued by the Convener TSECET.

Procedure:

The College issues an advertisement after necessary approval. The spot admissions will be made according to the guidelines issued from time to time by the Convener TSECET.

All admissions made at institute level (Spot Admissions) are subject to approval of competent authorities.

2.	<u>POST GRADUATE ADMISSION (PG):-</u>
	The admission into Postgraduate engineering and Technology programmes (M.Tech) for all the specializations of study are made as per the rules of the Telangana State Council of Higher Education (TSCHE).
2.1	<p><u>Admission to the M.Tech Two year Post Graduate Degree Programme in Engineering</u></p> <p>a. 70% seats i.e., "Category-A" seats (based on the rank obtained in state level entrance examination-TSPGECET and GATE) will be filled by the Convener TSPGECET.</p> <p>b. 30% seats i.e., "Category-B seats" will be filled by the management as per the Rules issued by the Government and guidelines from time to time issued by the TSCHE.</p> <p><i>All admissions made at institute level (Spot Admissions and Category-B) are subject to approval of competent authorities.</i></p>
2.2	<p><u>Spot Admission Procedure for M.TECH:</u></p> <p>Any seats left vacant in the convener quota will be filled based on the guidelines given by the Convener TSPGECET.</p> <p>Procedure: The College issues an advertisement after necessary approval. The spot admissions will be made according to the guidelines issued from time to time by the Convener TSPGECET.</p> <p><i>All admissions made at institute level (Spot Admissions and Category-B) are subject to approval of competent authorities.</i></p>
